Authors:

At least one author per paper must be registered at the full registration rate, regardless of whether or not they are students. For authors with multiple papers, one registration is required for each paper but additional papers have a specific fee (Student IEEE Member Early registration fee). The deadline for author registration is **June 24**^h, **2025.**

Students:

Student fees are applicable only to full-time students. Students must be able to provide a proof of their student status (student ID card or certificate).

Substitution:

If you are unable to attend the conference, you can request the transfer of your registration to another participant by notifying the conference secretariat before the conference.
